FIRST BAPTIST CHURCH O'FALLON CREATION CORNER (CC)

For further explanation, please refer to the Baptist Faith and Message, 2000.

Parents and students are expected to honor and not contradict the Statement of Faith which guide the mission of First Baptist Church O'Fallon (FBCO)/Creation Corner (CC). They are:

ABOUT GOD: God is the Creator and Ruler of the universe. He has eternally existed in three personalities: the Father, the Son, and the Holy Spirit. These three are co-equal and are one God. *Genesis 1:1, 26-27; Genesis 3:22; Psalm 90:2; Matthew 28:19; I Peter 1:2; II Corinthians 13:14.*

ABOUT JESUS CHRIST: Jesus is the Son of God. He is co-equal with the Father. Jesus lived a sinless human life and offered Himself as the perfect sacrifice for the sins of all people by dying on a cross. He arose from the dead after three days to demonstrate His power over sin and death. He ascended to Heaven's glory and will return again someday to earth to reign as King of kings and Lord of lords.

Matthew 1:22-23; Isaiah 9:6; John 1:1-5; Hebrews 4:14-15; I Corinthians 15:3-4; Romans 1:3-4; Acts 1:9-11; I Timothy 6:14-15; Titus 2:13.

ABOUT MARRIAGE, SEXUALITY, AND SEXUAL IDENTITY: We believe that biblical marriage as sanctioned by God joins one man and one woman in a single, exclusive union, as stated in Scripture (Gen. 2:18-25). We believe that God intends sexual intimacy to be limited to a man and a woman who are married to each other (I Cor. 6:18; 7:2-5; Heb. 13:4). Other forms of sexual activity (immorality including but not limited to: adultery, fornication, homosexual behavior, bisexual conduct, bestiality, incest, and use of pornography) are considered sinful as stated in Scripture and offensive to God (Matt. 15:18-20). We believe that in order to preserve the integrity of the church as the local Body of Christ, and all the ministries of the church, and to provide a biblical role model to the church members and community, it is imperative that all persons employed by the church/school in any capacity, or who serve as volunteers, or children attending CC, abide by and agree to this statement of faith on marriage, gender, and sexuality, and conduct themselves accordingly (Matt. 5:16; Phil. 2:14-16; I Thess. 5:22). While holding firm to Scripture's definition of marriage, gender, and sexuality, we believe that every person is deserving of compassion, love, kindness, respect, and dignity (Mark 12:28-31; Luke 6:31). LIFESTYLE STATEMENTS WHAT WE PRACTICE

BIBLE AS OUR SOLE AUTHORITY

Since God's Word is the only completely reliable and truthful authority, we accept the Bible as our manual for living. Our first question when faced with a decision is "What does the Bible say?" We practice daily Bible reading and Bible study. The Bible is the basis for all we believe.

AUTONOMY OF EACH LOCAL CHURCH

Christ is the recognized head of our church, not any person, group, or religious organization. While recognizing the value of associating and cooperating with other groups of Christians, we believe every local church should be self-governing and independent from any denominational control.

PRIESTHOOD OF EVERY BELIEVER

The Bible teaches that every Christian is called to "full-time" Christian service, regardless of his or her vocation. We practice the truth that every believer is a minister by encouraging every member to find a place of service and ministry. Every believer has direct access to God through prayer and Bible reading.

SPIRITUAL GROWTH

We believe we are commanded to "grow in grace and in the knowledge of our Lord and Savior Jesus Christ" so we seek to regularly participate in spiritual growth opportunities. Examples include, but are not limited to, the church's LIFE Groups, Discipleship Training program, fellowship with other believers, corporate worship, ministry, and service.

TITHING

At First Baptist Church O'Fallon, we practice tithing for the support of Christ's body, the church, and as God commands. We recognize that giving 10% of our gross income is the Biblical standard of giving.

IMMERSION

We practice baptism by immersion under water - the way Jesus was baptized, and the way the Bible commands.

SPIRIT-LED LIVING

We believe the only way it is possible to live the Christian life is by God's power within us. Therefore, we seek to practice a daily dependence on God's Spirit to enable us to do what is right.

TELLING OTHERS ABOUT JESUS

It is the responsibility of every Christian to share the Good News with those God brings us into contact with. Not only will we invite our friends to church, but we will also look for opportunities to share JESUS with them.

CHRISTIAN CONDUCT

As Christian leaders, we do not want to do or say anything that might damage our Christian integrity or cause confusion among believers or non-believers. All leaders are to refrain from unchristian conduct or any type of behavior that might become a stumbling block to believers as well as non-believers. We believe that marriage is between one man and one woman as set forth in Genesis.
